#### Requirement

- To cater to a 15Amp 230V AC load
- To run 6 Hours during power cuts/failures

- Adequate deep cycle battery bank backup (Type, Brand, size and number of batteries with specifications)

- Over voltage and Low voltage protection devices

**Warranty and Support:** 1 Year Comprehensive Onsite (which covers onsite troubleshooting, Maintenance, and Repairs)

Under warranty period provides comprehensive onsite/remote Support Services for managing Powerwall System configuration and maintenance. It should provide expertise in UPS systems, Inverter and Batteries configuration, and maintenance for power-enabled establishments with refined health and safety protocols.

Maintenance Support will be carried out during normal office working hours (i.e. time from 10.00 am 05.00 pm. In case the defect is major and cannot be repaired at the working place, the vendor can take the same to their workshop/service center. All the costs, charges, and expenses in respect of transporting the equipment or part thereof shall be the vendor's responsibility as the same is deemed to be included in the maintenance contract.

<u>Preventive Maintenance:</u> It will be the responsibility of the successful Vendor to keep the system in full working condition. All defects related to battery or connectivity are also included in the scope of work.

The preventive maintenance of the System is to be carried out on a quarterly basis. **The Vendor is to give the list of preventive maintenance schedules that it intends to do on the critical parts along with the periodicity, procedures etc.** 

<u>AMC – Annual Maintenance Contract</u>: The Annual maintenance contract is a fully comprehensive on-site package that is going to activate after the warranty period expires. The repair/replacement of all spare parts, accessories, and maintenance are included in the package.

The contract will include the repair/replacement of all defective parts of the maintenance contract and would have to be replaced if defective during the period of a maintenance contract.

During the AMC period, the vendor shall carry out all necessary servicing/repairs to the equipment/system under AMC at the current location of the equipment/system.

Vendors need to mention the AMC Cost and subsequent annual percentage increment.
